IN EXERCISE of the powers contained in section *twenty-eight* of the Supreme Court Act, the following Rules are hereby made:

1. (i) These Rules may be cited as the Supreme Court (Amendment) Rules, 2000, and shall be read as one with the Supreme Court Rules, in these Rules referred to as the principal Rules.
